**1. The Contest**

Complete contest entry form with brief description of bathroom, year home was built and date of any recent renovations. Submit no more than 5 photos of the following:

- Entrance to bathroom - from hall looking into bath showing as much of the entire bath as possible
- tub/shower area
- toilet and overhead cabinet (if applicable)
- sink and medicine cabinet
- floor - from hall looking into the bathroom a picture of the floor

Contestant will be emailed automatic email reply to entry form. Contestant must print and bring this automatic email reply to the Home & Lifestyles Showcase during showcase hours – Friday, February 17, 2012, 5:00 PM – 9:00 PM, Saturday, February 18, 2012 10:00 AM – 7:00 PM and Sunday, February 19, 2012, 10:00 AM – 4:00 PM to be validated in order to be eligible for contest. Sponsor(s) will not be responsible for lost, late, misdirected, mutilated or otherwise undeliverable email reply document.

**4. Winner**

The winner will be determined by an independent panel of judges from all entries submitted at the Home & Lifestyles Showcase. The winner will be selected on or before February 27, 2012. Winner will be immediately notified. The winner must show legal proof of ownership of the premise involved. Winner will be required to execute a

declaration of eligibility form that winner has complied with all the rules and regulations of the contest.
